- 一、國立臺灣師範大學(以下簡稱本校)為審議教育實習相關之特殊個案與急切事宜，設置教育實習輔導委員會(以下簡稱本委員會)。
- 二、本委員會由本校師資培育學院(以下簡稱本學院)院長、各學院代表1-2名及教育實習機構代表1名組成之。本學院院長為主任委員，學院代表依學院規模及專業性，由各學院推薦教育實習指導教授，其中設有副院長之學院得推薦2名，其餘學院推薦1名。
- 三、本委員會委員之任期為一學年，得連任。委員如中途因職務或課程異動時，則另行遴選或延聘。
- 四、本委員會之職掌如下：
 - (一)有關實習生特殊個案之審議。
 - (二)有關教育實習相關議題之審核。
 - (三)有關優質教育實習機構之遴選及認證。
 - (四)有關教育實習法規爭議與疑點之判斷或解釋。
- 五、本委員會於必要時召開會議。
- 六、本委員會開會時應有委員過半數出席始得開議，有出席委員過半數之同意始成決議。
- 七、本委員會行政作業由本校師資培育學院實習與地方輔導組負責。
- 八、本委員會所處理事項須於下一次師資培育會議中報告。
- 九、本要點經師資培育會議通過，並簽奉校長核定後實施，修正時亦同。

The Guideline of the National Taiwan Normal University Educational Practice Guidance Committee

On March 16, 2005, it was approved at the Practice Guidance Meeting and the Teaching and Educational Practice Mentor Conference at the second semester of the 2014 academic year.

From March 22, 2005, it was implemented. On September 26, 2008, the amendment was approved at the meeting of Teacher Education and Employment Guidance at the first semester of the 2018 academic year.

On September 28, 2011, the amendment was approved at the meeting of Teacher Education and Employment Guidance at the first semester of the 2011 academic year.

On September 15, 2014, the amendment was approved at the meeting of Teacher Education and Employment Guidance at the second semester of the 2014 academic year.

On March 29, 2017, the amendment was approved at the meeting of Teacher Education and Employment Guidance at the second semester of the 2016 academic year.

On August 7, 2019, it was reviewed and approved by the 1st academic administrative meeting of the School of the Teacher Education at the 1st semester of the 2019 academic year

On October 16, 2019, it was reviewed and approved at the Teacher Education Meeting at the first semester of 2019 academic year.

1. National Taiwan Normal University, (hereinafter referred to as the university), established the Educational Practice Guidance Committee to review special cases and urgent matters related to educational practice (hereinafter referred to as the committee).

2. The Committee is composed of the dean of the School of Teacher Education (hereinafter referred to as the school), 1 or 2 representatives from other schools and 1 representative from practice institutions. The dean of the school is the chairman, and the representatives of the other schools are represented according to the scale and professionalism of the school. The schools shall recommend educational practice mentors, among which the school with a vice president could recommend 2 mentors, and the other school could recommend 1 mentor.

3. The term of the committee members is one academic year and may be re-elected. The committee member may be re-elected separately due to the changes of duties or courses of the member.

4. The functions of this committee are as follows:

- (1) Review on special cases of educational practice.
- (2) Review of issues related to educational practice.
- (3) Select and certificate of high-quality educational practice institutions.

(4) Decide or interpret disputes and doubts about educational practice regulations

5. The Committee shall hold meetings when necessary.

6. When the committee is in session, more than half of the members should be present and the resolution can only be made with the consent of more than half of the members present.

7. The administration of this committee is supported by the Division of Educational Practicum and Professional Development of the school.

8. The matters dealt with by this committee shall be reported in the next Teacher Education Meeting.

9. The guideline and amendment shall be implemented after being approved by the Teacher Education Meeting and signed by the principal of the university.
